

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Tohono O'odham Nation Health Care Facilities**  
**Management Budget Amendment No. 1)**

**RESOLUTION NO. 19-014**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Tohono O'odham Nation Health Care ("TONHC") Facilities  
8 Management Budget in the amount of \$5,033,805.81 was approved by Resolution  
9 No. 18-344; and

10 **WHEREAS,** the Tohono O'odham Nation Health Care has prepared and submitted for review  
11 and approval its FY 2019 TONHC Facilities Management Budget Amendment No.  
12 1, which is incorporated by this reference and which will adjust personnel,  
13 operational, and indirect cost charges line items; and

14 **WHEREAS,** the FY 2019 Tohono O'odham Nation Health Care Facilities Management Budget  
15 Amendment No. 1 will decrease the FY 2019 TONHC Facilities Management Budget  
16 Amendment No. 1 by \$7,249.65 from \$5,033,805.81 to \$5,026,556.16; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
18 reviewed the FY 2019 Tohono O'odham Nation Health Care Facilities Management  
19 Budget Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
21 **FY 2019 Tohono O'odham Nation Health Care Facilities Management Budget**  
22 **Amendment No. 1, which includes a \$7,249.65 decrease from \$5,033,805.81 to**  
23 **\$5,026,556.16.**

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
25 Nation chairperson or any designated official is authorized to administer and  
26 expend the FY 2019 Tohono O'odham Nation Health Care Facilities Management  
27 Budget as amended, provided that any amendments or modifications shall be  
28 submitted for prior approval by the Tohono O'odham Legislative Council.

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
30 **day of JANUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
31 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat.984).**
