

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2019 Attorney Contract between the Tohono O'odham Nation
and The Clark Law Firm, P.C.)**

RESOLUTION NO. 19-016

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "to employ legal counsel for the protection and advancement of the**
3 **Tohono O'odham Nation..." (Constitution of the Tohono O'odham Nation, Article**
4 **VI, Section 2(a)); and**

5 **WHEREAS, it is advisable that the Human Resources Department has available independent**
6 **legal representation for employment issues in which the Office of Attorney**
7 **General is unable to provide legal advice due to conflicts of interest; and**

8 **WHEREAS, the Human Resources Department prepared and submitted for review an**
9 **Attorney Contract with The Clark Law Firm, P.C. to provide legal representation**
10 **to the Human Resources Department; and**

11 **WHEREAS, the Human Resources Development and Domestic Affairs Committees have**
12 **reviewed the Attorney Contract and recommend its approval.**

13 **NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **FY 2019 Attorney Contract between the Tohono O'odham Nation and The Clark**
15 **Law Firm, P.C., in the amount of \$15,000 for the period of October 1, 2018 through**
16 **September 30, 2019.**

17 **BE IT FINALLY RESOLVED that the funding of the Attorney Contract shall be provided from the**
18 **Human Resources Budget and that the Chairman of the Nation is authorized to**
19 **execute the Attorney Contract in substantially the form attached.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
21 **day of JANUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat.984).**
