

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Baboquivari District Administration and Choulic  
Community Budget Amendments No. 1)**

**RESOLUTION NO. 19-021**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2019 Baboquivari District Budgets in the amount of \$3,955,217.99 was  
13 authorized by Baboquivari District Council Resolution No. 2018-B-66 and  
14 approved by Legislative Council Resolution No. 18-381; and

15 **WHEREAS,** by Baboquivari District Council Resolution No. 2018-B-87, the Baboquivari  
16 District has authorized and submitted for review and approval its FY 2019  
17 Baboquivari District Budget Amendment No. 1, which is incorporated by this  
18 reference and which will adjust operational and personnel line items; and

19 **WHEREAS,** the FY 2019 Baboquivari District Administration Budget Amendment No. 1 will  
20 increase the FY 2019 Baboquivari District Administration Budget by \$105,318.30  
21 from \$1,066,895.84 to \$1,172,214.14; and

22 **WHEREAS,** by Baboquivari District Council Resolution No. 2018-B-91, the Baboquivari  
23 District Council has authorized and submitted for review and approval its FY 2019  
24 Baboquivari District Choulic Community Budget Amendment No. 1, which is  
25 incorporated by this reference and which will adjust operational line items; and

26 **WHEREAS,** the FY 2019 Baboquivari District Choulic Community Budget Amendment No. 1  
27 will increase the FY 2019 Choulic Community Budget by \$55,299.35 from  
28 \$446,858.40 to \$502,157.75; and

29 **WHEREAS,** the Budget and Finance Committee has reviewed FY 2019 Baboquivari District  
30 Budget Amendment No. 1 and FY 2019 Choulic Community Budget Amendment  
31 No. 1 and recommends approval.

32 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves:

- 33 (1) **FY 2019 Baboquivari District Administration Budget Amendment No. 1**  
34 **which includes a \$105,318.30 increase from \$1,066,895.84 to \$1,172,214.14**

1 that shall be funded by FY 2014 Baboquivari District Administration  
2 carryover funds; and

- 3 (2) FY 2019 Baboquivari District Choulic Community Budget Amendment No. 1  
4 which includes a \$55,299.35 increase from \$446,858.40 to \$502,157.75 that  
5 shall be funded by FY 2014 Choulic Community carryover funds.

6 **BE IT FURTHER RESOLVED** that the FY 2019 Baboquivari District Administration Budget  
7 Amendment No. 1 and FY 2019 Choulic Community Budget Amendment No. 1 will  
8 increase the overall FY 2019 Baboquivari District Budgets from \$3,955,217.99 to  
9 \$4,115,835.64.

10 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019  
11 Baboquivari District Budgets as amended shall be managed and expended in  
12 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham  
13 Nation and the Nation's laws, provided that any amendments or modifications  
14 shall be authorized under District Council resolution and submitted for prior  
15 approval by the Tohono O'odham Legislative Council.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>  
17 day of JANUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-  
18 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
19 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
20 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
22 (48 Stat.984).
