

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Tribal
Food Distribution Budget Amendment No. 1)**

RESOLUTION NO. 19-023

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Health and Human Services ("DHHS"), Tribal Food**
8 **Distribution Budget in the amount of \$86,777.00 was approved by Resolution No.**
9 **18-339; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2019 Tribal Food Distribution Budget Amendment No.**
12 **1, which is incorporated by this reference, and which will adjust operational**
13 **and/or personnel line items; and**

14 **WHEREAS, the FY 2019 DHHS Tribal Food Distribution Budget Amendment No. 1 will increase**
15 **the FY 2019 Tribal Food Distribution Budget by \$26,554.00 from \$86,777.00 to**
16 **\$113,331.00; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2019 DHHS Tribal Food Distribution Budget Amendment No. 1**
19 **and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2019 Department of Health and Human Services Tribal Food Distribution**
22 **Budget Amendment No. 1, which includes a \$26,554.00 increase from \$86,777.00**
23 **to \$113,331.00 that shall be funded by the Nation's general fund.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Chairperson or any designated official is authorized to administer and expend**
26 **the FY 2019 Department of Health and Human Services Tribal Food Distribution**
27 **Budget as amended, provided that any amendments or modifications shall be**
28 **submitted for prior approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11th**
30 **day of JANUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
