

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Office of the Treasurer Budget Amendment No. 1)**

RESOLUTION NO. 19-029

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Office of the Treasurer Budget in the amount of \$851,766.66 was**
8 **approved by Resolution No. 18-296; and**

9 **WHEREAS, the Office of the Treasurer has prepared and submitted for review and approval**
10 **its FY 2019 Office of the Treasurer Budget Amendment No. 1 which is incorporated**
11 **by this reference and which will adjust operational and/or personnel line items;**
12 **and**

13 **WHEREAS, the FY 2019 Office of the Treasurer Budget Amendment No. 1 will increase the FY**
14 **2019 Office of the Treasurer Budget by \$322,292.85 from \$851,766.66 to**
15 **\$1,174,059.51; and**

16 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Office of the**
17 **Treasurer Budget Amendment No. 1 and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves FY**
19 **2019 Office of the Treasurer Budget Amendment No. 1 effective October 1, 2018,**
20 **which includes a \$322,292.85 increase from \$851,766.66 to \$1,174,059.51 that**
21 **shall be funded by the Nation's general fund surplus.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson and any designated official is authorized to administer and**
24 **expend the FY 2019 Office of the Treasurer Budget as amended, provided**
25 **however, that any amendments or modifications shall be submitted for prior**
26 **approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
28 **day of JANUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (d)(3) of the Constitution of the Tohono O'odham Nation, adopted**
31 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**
