

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Public Safety Environmental Protection
Office Brownfields Budget Amendment No. 1)**

RESOLUTION NO. 19-032

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the Nation and its members" provided that "all**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Public Safety Environmental Protection Office ("EPO")**
8 **Brownfields Budget in the amount of \$137,693.48 was approved by Resolution No.**
9 **18-320; and**

10 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
11 **approval its FY 2019 EPO Brownfields Budget Amendment No. 1, which is**
12 **incorporated by this reference and which will adjust personnel and/or**
13 **operational line items; and**

14 **WHEREAS, the FY 2019 Department of Public Safety EPO Brownfields Budget Amendment No.**
15 **1 will decrease the Department of Public Safety EPO FY 2019 Brownfields Budget**
16 **by \$693.48 from \$137,693.48 to \$137,000.00; and**

17 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
18 **2019 Department of Public Safety EPO Brownfields Budget Amendment No. 1 and**
19 **recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2019 Department of Public Safety EPO Brownfields Budget Amendment No. 1,**
22 **which includes a decrease of \$693.48 from \$137,693.48 to \$137,000.00.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Department of Public Safety EPO Brownfields Budget as**
26 **amended, provided however, that any amendments or modifications shall be**
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
29 **day of JANUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
