

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment No. 2 to the Professional Service Agreement between  
the Tohono O'odham Nation and Motorola Solutions, Inc.)**

**RESOLUTION NO. 19-035**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the Nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Public Safety Law Enforcement has established a Professional**  
8 **Service Agreement with Motorola Solutions, Inc. and was accepted and approved**  
9 **by Tohono O'odham Legislative Council Resolution No. 17-573; and**

10 **WHEREAS, the Department of Public Safety Law Enforcement amended the Professional**  
11 **Service Agreement with Amendment 1 and was accepted and approved by the**  
12 **Tohono O'odham Legislative Council thru Resolution No. 18-401; and**

13 **WHEREAS, the Department of Public Safety Law Enforcement is amending the Agreement**  
14 **with Amendment 2 to increase the Agreement amount and extend the Agreement**  
15 **date to September 30, 2019; and**

16 **WHEREAS, the Department of Public Safety Law Enforcement has utilized 638 2017 carryover**  
17 **savings to fund the project; and**

18 **WHEREAS, the Department of Public Safety Law Enforcement has received two Change Order**  
19 **Notices for additional equipment and installs for the K2 Core, MCC7500 Console**  
20 **and Emergency Call Works 911 Dispatching System which changes the total cost;**  
21 **and**

22 **WHEREAS, the Department of Public Safety Law Enforcement has received a third Change**  
23 **order Notice for additional cost for extending the project date; and**

24 **WHEREAS, the Department of Public Safety Law Enforcement has amended the Professional**  
25 **Service Agreement with Motorola Solutions, Inc. by adding the Change Order**  
26 **Notice three (3); which will change the total amount from \$1,073,512.10 to**  
27 **\$1,089,995.50 a difference of \$16,483.40; and**

28 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed**  
29 **Amendment No. 2 the Professional Service Agreement with the Tohono O'odham**  
30 **Nation and Motorola Solutions, Inc. and recommend its approval.**

31 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
32 **Amendment No. 2 to the Professional Service Agreement between the Tohono**  
33 **O'odham Nation and Motorola Solutions, Inc. substantially in the form as**  
34 **attached hereto, and authorizes the Nation's chairperson or any designated**

official to execute it provided however, that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> day of JANUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
