

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognizing the San Xavier District Council Appointment of Adam Andrews as
Alternate to Representative Janice Felix)

LEGISLATIVE ORDER NO. 19-040

1 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council**
2 **to "enact laws and ordinances for conducting and regulating elections" and**
3 **provides that the "decision of the Tohono O'odham Council in all election**
4 **matters, including the eligibility and qualifications of candidates, shall be final"**
5 **(Constitution, Article VI, Section 1(g) and Article X, Section 7); and**

6 **WHEREAS, the Legislative Council alternate seat to San Xavier District Representative Janice**
7 **Felix is vacant; and**

8 **WHEREAS, pursuant to 12 T.O.C. Chapter 1, Section 1505(B)(3), when a Legislative Council**
9 **alternate's seat is vacant, a district may "adopt a resolution appointing an**
10 **alternate who shall hold office for the unexpired term of his or her predecessor;**
11 **provided that the alternate shall not be seated until the Board certifies in writing**
12 **that the alternate meets all the qualifications for that office"; and**

13 **WHEREAS, on December 11, 2018, the San Xavier District Council appointed Adam Andrews**
14 **to serve as alternate to Representative Janice Felix on the Legislative Council (San**
15 **Xavier District Resolution No. SXDC 12-18-03); and**

16 **WHEREAS, by letter dated January 11, 2019, the Election Board has certified in writing that**
17 **Adam Andrews meets all the qualifications for the office of Legislative Council**
18 **alternate.**

19 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council recognizes the**
20 **San Xavier District Council appointment of Adam Andrews to serve as alternate to**
21 **Representative Janice Felix and seats alternate Adam Andrews, who shall serve in**
22 **accordance with the Constitution and laws of the Tohono O'odham Nation and**
23 **with the rules and procedures of the Legislative Council when Representative**
24 **Janice Felix is unable to attend a Legislative Council session.**

25 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 17TH day of**
26 **JANUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
27 **AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(g) and Article X, Section 7 of the Constitution of the Tohono O'odham Nation,**
29 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
31 **Act of June 18, 1934 (48 Stat.984).**


