

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of Behavioral Health Tas Tonlik Ki/SMI Program Revenue Budget Amendment No. 1)

RESOLUTION NO. 19-042

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Department of Health and Human Services Division of Behavioral
8 Health Tas Tonlik Ki/SMI Program Revenue Budget in the amount of
9 \$1,066,353.00 was approved by Resolution No. 18-327; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
11 review and approval its FY 2019 Division of Behavioral Health Tas Tonlik Ki/ SMI
12 Program Revenue Budget Amendment No. 1, which is incorporated by this
13 reference and which adjusts personnel, operational line items and adds new line
14 items; and

15 **WHEREAS,** the FY 2019 Department of Health and Human Services Division of Behavioral
16 Health Tas Tonlik Ki/SMI Program Revenue Budget Amendment No. 1 will
17 increase the FY 2019 Division of Behavioral Health Tas Tonlik Ki/SMI Program
18 Revenue Budget by \$520,107.00 from \$1,066,353.00 to \$1,586,460.00; and

19 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
20 reviewed the FY 2019 Department of Health and Human Services Division of
21 Behavioral Health Tas Tonlik Ki/SMI Program Revenue Budget Amendment No. 1
22 and recommend its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 FY 2019 Department of Health and Human Services Division of Behavioral Health
25 Tas Tonlik Ki/SMI Program Revenue Budget Amendment No. 1 effective October
26 1, 2018, which includes a \$520,107.00 increase from \$1,066,353.00 to \$1,586,460.00
27 that shall be funded by program revenues.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
29 Nation chairperson or any designated official is authorized to administer and
30 expend the FY 2019 Department of Health and Human Services Division of
31 Behavioral Health Tas Tonlik Ki/SMI Program Revenue Budget as amended,
32 provided however, that any amendments or modifications shall be submitted for
33 prior approval by the Tohono O'odham Legislative Council.
