RESOLUTION NO. 19-048

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making recommendations to the Legislative Council regarding the eligibility of**
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
10 **O'odham Legislative Council shall determine whether an application is approved**
11 **for membership and its determination, along with the resolution number and**
12 **date of enactment, shall be provided to the applicant; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
14 **membership and adoption applications misspelled or incorrectly listed the**
15 **names of members and/or incorrectly listed enrollment numbers; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 32-80, 138-**
17 **87, 91-308, 99-475, 01-050, 01-183, 01-263, 01-449, 01-496, 01-589, 02-180, 03-280**
18 **and 13-393 be amended to reflect the correct name and/or enrollment number**
19 **for the members identified in the February 2019 Corrected Enrollment**
20 **Resolution Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 32-80, 138-87, 91-308, 99-475, 01-050, 01-183, 01-263, 01-449, 01-496, 01-589,**
23 **02-180, 03-280 and 13-393 are amended upon the effective date of those**
24 **resolutions to reflect the correct name and/or enrollment number for the**
25 **members identified in the February 2019 Corrected Enrollment Resolution**
26 **Summary.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
28 **day of FEBRUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
30 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
31 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
33 **16 of the Act of June 18, 1934 (48 Stat.984).**
