

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of Health
Transportation Service Budget Amendment No. 1)**

RESOLUTION NO. 19-052

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Health and Human Services ("DHHS") Division of**
8 **Health Transportation Service Budget in the amount of \$2,241,602.00 was**
9 **approved by Resolution No. 18-339 and subsequent funding in the amount of**
10 **\$1,500,000.00 from Health Transportation Service revenue funding was approved**
11 **by Resolution No. 18-326; and**

12 **WHEREAS, the DHHS has prepared and submitted for review and approval its FY 2019 Health**
13 **Transportation Service Budget Amendment No. 1, which is incorporated by this**
14 **reference and which will adjust personnel and/or operational line items; and**

15 **WHEREAS, the FY 2019 DHHS Division of Health Transportation Service Budget Amendment**
16 **No. 1 will not change the total budget amount of \$3,741,602.00; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2019 DHHS Division of Health Transportation Service Budget**
19 **Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2019 DHHS Division of Health Transportation Service Budget Amendment No.1**
22 **effective October 1, 2018, which will not change the total budget amount of**
23 **\$3,741,602.00.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2019 Department of Health and Human Services Division of Health**
27 **Transportation Service Budget as amended, provided, that any amendments or**
28 **modifications shall be submitted for prior approval by the Tohono O'odham**
29 **Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
31 **day of FEBRUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
32 **-0- AGAINST; [01] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
