

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the First Things First Intergovernmental Agreement between the Tohono O'odham Nation Regional Partnership Council, Arizona Early Childhood Development and Health Board, and the Tohono O'odham Nation)

RESOLUTION NO. 19-057

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to "consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**
5 **or with private persons or organizations on all matters within the authority of the**
6 **Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and**

7 **WHEREAS, the Tohono O'odham Nation recognizes and prioritizes the importance of health,**
8 **education, and general wellbeing of the children of the Nation; and**

9 **WHEREAS, by Proposition 203, the First Things First Initiative was passed by Arizona voters**
10 **in 2006 and increases the quality and access to early childhood programs that**
11 **helps ensure that all Arizona children enter school healthy and ready to learn;**
12 **and**

13 **WHEREAS, the First Things First intergovernmental agreement ("IGA"), which is**
14 **incorporated by this reference, provides the Tohono O'odham Nation with**
15 **funding, updates the Standards of Practice, and renews the term of agreement**
16 **from July 1, 2018 through June 30, 2019 with the option to renew for up to three**
17 **annual extensions; and**

18 **WHEREAS, the Health and Human Services Committee has reviewed the First Things First**
19 **IGA and recommends its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **First Things First IGA and authorizes the Tohono O'odham Nation Chairperson to**
22 **execute it in substantially the form attached; provided that any amendment to**
23 **the IGA be submitted to the Legislative Council for prior approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
25 **day of FEBRUARY, 2019 at a meeting at which a quorum was present with a vote of 2,875.6 FOR;**
26 **-0- AGAINST; -0- NOT VOTING; and 209.0[04] ABSENT, pursuant to the powers vested in the**
27 **Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by**
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat.984).**
