

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Veterans Affairs Office Donations and Contributions**  
**Budget Amendment No. 2)**

**RESOLUTION NO. 19-063**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Veterans Affairs Office Donations and Contributions Budget in the**  
8 **amount of \$67,883.58 was approved by Resolution No. 18-359, and amended by**  
9 **Resolution No. 18-463 in the amount of \$68,383.58; and**

10 **WHEREAS, the Veterans Affairs Office has prepared and submitted for review and approval**  
11 **its FY 2019 Veterans Affairs Office Donations and Contributions Budget**  
12 **Amendment No. 2, which is incorporated by this reference and which will adjust**  
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2019 Veterans Affairs Office Donations and Contributions Budget**  
15 **Amendment No. 2 will increase the FY 2019 Veterans Affairs Office Donations and**  
16 **Contributions Budget by \$5,500.00 from \$68,383.58 to \$73,883.58; and**

17 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
18 **reviewed the FY 2019 Veterans Affairs Office Donations and Contributions Budget**  
19 **Amendment No. 2 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2019 Veterans Affairs Office Donations and Contributions Budget Amendment**  
22 **No. 2, which includes a \$5,500.00 increase from \$68,383.58 to \$73,883.58, that shall**  
23 **be funded by revenue donations.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation chairperson or any designated official is authorized to administer and**  
26 **expend the FY 2019 Veterans Affairs Office Donations and Contributions Budget**  
27 **as amended, provided that any amendments or modifications shall be submitted**  
28 **for prior approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
30 **day of FEBRUARY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**  
31 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
32 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat.984).**
