

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Department of Public Safety 638 Corrections Program  
Budget Amendment No. 2)**

**RESOLUTION NO. 19-073**

1     **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2     **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3     **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4     **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5     **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6     **Nation, Article VI, Section 1(d)(2)); and**

7     **WHEREAS, the FY 2019 Department of Public Safety 638 Corrections Program Budget in the**  
8     **amount of \$4,432,897.04 was approved by Resolution No. 18-299 and subsequently**  
9     **amended by Resolution No. 19-031; and**

10    **WHEREAS, the Department of Public Safety has prepared and submitted for review and**  
11    **approval its FY 2019 638 Corrections Program Budget Amendment No. 2, which is**  
12    **incorporated by this reference and which will adjust capital costs; and**

13    **WHEREAS, the FY 2019 Department of Public Safety 638 Corrections Program Budget**  
14    **Amendment No. 2 will increase the FY 2019 638 Corrections Program Budget by**  
15    **\$1,100,000.00 from \$4,432,897.04 to \$5,532,897.04; and**

16    **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**  
17    **2019 Department of Public Safety 638 Corrections Program Budget Amendment**  
18    **No. 2 and recommend its approval.**

19    **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20    **FY 2019 Department of Public Safety 638 Corrections Program Budget**  
21    **Amendment No. 2, effective October 1, 2018, which includes a \$1,100,000.00**  
22    **increase from \$4,432,897.04 to \$5,532,897.04 that shall be funded by the FY 2017**  
23    **Department of Public Safety 638 Corrections Program Budget carryover savings.**

24    **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25    **Nation chairperson or any designated official is authorized to administer and**  
26    **expend the FY 2019 Department of Public Safety 638 Corrections Program Budget**  
27    **as amended, provided however, that any amendments or modifications shall be**  
28    **submitted for prior approval by the Tohono O'odham Legislative Council.**

29    **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>**  
30    **day of MARCH, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
31    **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
32    **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
33    **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34    **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35    **18, 1934 (48 Stat.984).**
