

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Senior Services Title VI Part A Budget Amendment No. 2)

RESOLUTION NO. 19-075

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Human Services ("DHHS") Division of Senior Services**
8 **Title VI Part A Budget Amendment No. 1 in the amount of \$262,593.91 was**
9 **approved by Resolution No. 18-483; and**

10 **WHEREAS, the DHHS has prepared and submitted for review and approval its FY 2019**
11 **Division of Senior Services Title VI Part A Budget Amendment No. 2, which is**
12 **incorporated by this reference and which will adjust personnel and/or**
13 **operational line items; and**

14 **WHEREAS, the FY 2019 DHHS Division of Senior Services Title VI Part A Budget Amendment**
15 **No. 2 will not change the total budget amount; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
17 **reviewed the FY 2019 DHHS Division of Senior Services Title VI Budget**
18 **Amendment No. 2 and recommend their approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2019 Department of Health and Human Services Division of Senior Services**
21 **Title VI Part A Budget Amendment No. 2 effective October 1, 2018, which will not**
22 **change the budget amount of \$262,593.91.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Department of Health and Human Services Division of Senior**
26 **Services Title VI Part A Budget as amended, provided however, that any**
27 **amendments or modifications shall be submitted to the Tohono O'odham**
28 **Legislative Council for prior approval.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
30 **day of MARCH, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
