

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Transfer of Funds to the Schuk Toak District RVC Wealth  
Management Investment Account)**

**RESOLUTION NO. 19-079**

1     **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2     **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3     **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4     **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5     **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6     **Nation, Article VI, Section 1(d)(2)); and**

7     **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
8     **Nation,**

9             **No district council shall expend district funds except pursuant to budgets**  
10            **authorized under resolutions of the district council and approved by the**  
11            **Tohono O'odham Council. The management of these funds shall be only by**  
12            **a treasurer or other authorized officer of the district council who has**  
13            **furnished a surety bond satisfactory to the treasurer of the Tohono**  
14            **O'odham Nation, and all expenditures of these funds shall be by checks**  
15            **signed by such treasurer or other authorized officer and the chairman or**  
16            **vice chairman of the district council.**

17            **; and**

18     **WHEREAS, the Schuk Toak District ("District") had reviewed the allocation of the Mining**  
19     **Royalties and the U.S. Department of the Interior, Office of Special Trustees Labor**  
20     **Accounts Ending in 5701 and 8705 by Resolution Nos. 18-143, 18-242, and 18-238**  
21     **by equal distribution or held in accounts on the District's behalf in the total**  
22     **amount of \$552,933.55; and**

23     **WHEREAS, by Resolution No. ST-02-14-19-016, the Schuk Toak District has approved to**  
24     **transfer its allocations into an RVC Wealth Management Investment for future**  
25     **projects for the Schuk Toak District pursuant to Article IX, Section 7 of the Tohono**  
26     **O'odham Nation's Constitution; and**

27     **WHEREAS, the Budget and Finance Committee reviewed the request to transfer funds to the**  
28     **Schuk Toak District and recommends its approval.**

29     **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
30     **transfer of remaining Mining Royalties and the U.S. Department of the Interior,**  
31     **Office of Special Trustees Labor Accounts Ending in 5701 and 8705 in the total**  
32     **amount of \$552,933.55 to the Schuk Toak District RVC Wealth Management**  
33     **Investment, provided that any expenditure of these funds are subject to a budget**
