

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Schuk Toak District – Santa Rosa Ranch Community
Budget Amendment No. 1)

RESOLUTION NO. 19-080

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** the FY 2019 Schuk Toak District Budget in the amount of \$4,220,905.49 was
13 **authorized by Schuk Toak District Council Resolution No. ST-08-30-18-072 and**
14 **approved by Legislative Council Resolution No. 18-389; and**

15 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-02-23-19-020, the Schuk Toak
16 **District has authorized and submitted for review and approval its FY 2019 Schuk**
17 **Toak District – Santa Rosa Ranch Community Budget Amendment No. 1, which is**
18 **incorporated by this reference and which will adjust operational and/or**
19 **personnel line items; and**

20 **WHEREAS,** the FY 2019 Schuk Toak District – Santa Rosa Ranch Community Budget
21 **Amendment No. 1 will not change the total budget amount; and**

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Schuk Toak District
23 **– Santa Rosa Ranch Community Budget Amendment No. 1 and recommends its**
24 **approval.**

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 **FY 2019 Schuk Toak District – Santa Rosa Ranch Community Budget Amendment**
27 **No. 1, which does not change the total budget amount of \$4,220,905.49.**

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019 Schuk
29 **Toak District – Santa Rosa Ranch Community Budget as amended shall be**
30 **managed and expended in accordance with Article IX, Section 7 of the**
31 **Constitution of the Tohono O'odham Nation and the Nation's laws, provided that**
32 **any amendments or modifications shall be authorized under District Council**
33 **resolution and submitted for prior approval by the Tohono O'odham Legislative**
34 **Council.**

6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat.984).


