

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Sells District ASARCO Mining Budgets)**

**RESOLUTION NO. 19-081**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** by Resolution No. 18-242, the Legislative Council authorized the distribution of  
13 ASARCO mining royalties held at the U.S. Department of the Interior, Office of the  
14 Special Trustee making available district allocations subject to budgets  
15 approved in accordance with Article VI, Section 1(d)(2) and Article IX, Section 7 of  
16 the Nation's Constitution; and

17 **WHEREAS,** by Sells District Council Resolutions No. SD-105-18 and SD-03-19, the Sells District  
18 has authorized the Sells District FY 2019 ASARCO Mining Budgets, which are  
19 incorporated by this reference, in the amount of \$372,121.10; and

20 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Sells District  
21 ASARCO Mining Budgets and recommends their approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
23 FY 2019 Sells District ASARCO Mining Budgets in the amount of \$372,121.10 that  
24 shall be funded by ASARCO mining royalty funds.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019 Sells  
26 District ASARCO Mining Budgets shall be managed and expended in accordance  
27 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and  
28 the Nation's laws, provided that any amendments or modifications shall be  
29 authorized under District Council resolution and submitted for prior approval by  
30 the Tohono O'odham Legislative Council.

31 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>  
32 day of MARCH, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-  
33 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
34 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
35 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
36 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
37 (48 Stat.984).
