

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 19-066 "Approving Enrollment or Adoption
Applications for Membership in the Tohono O'odham Nation for
March 2019," to Delete Members who were Approved Twice)**

RESOLUTION NO. 19-089

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws
2 and ordinances governing the enrollment and adoption of members (Article VI,
3 Section 1(h) of the Constitution of the Tohono O'odham Nation); and

4 **WHEREAS,** Articles VI and VII of the Nation's Enrollment Ordinance provide that the
5 Enrollment Committee is responsible for reviewing enrollment applications and
6 making recommendations to the Legislative Council regarding the eligibility of
7 applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and

8 **WHEREAS,** the Enrollment Committee has determined that members were originally
9 approved for membership by Resolution No. 19-045 and that these same
10 members were mistakenly approved a second time for membership by
11 Resolution No. 19-066; and

12 **WHEREAS,** the Enrollment Committee therefore recommends that Resolution No. 19-066 be
13 amended to delete the members identified in the attached Amending Enrollment
14 Resolution List March for 2019; and

15 **WHEREAS,** the members that were originally approved in Resolution No. 19-045 will retain
16 the roll number and approval date identified in that resolution.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council amends
18 Resolution No. 19-066 "Approving Enrollment or Adoption Applications for
19 Membership in the Tohono O'odham Nation for March 2019," upon the effective
20 date of that resolution by deleting the members and corresponding information
21 identified in the attached Amending Enrollment Resolution List March 2019.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND
23 day of MARCH, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-
24 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
25 Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham
26 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
27 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
28 16 of the Act of June 18, 1934 (48 Stat.984).
