

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Chukut Kuk District Budget Amendment No. 2)

RESOLUTION NO. 19-090

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Chukut Kuk District Resolution No. 2018-40 the Chukut Kuk District Council
13 authorized its FY 2019 Chukut Kuk District Budget which is incorporated by this
14 reference in the amount of \$2,017,635.31 and authorized to expend funds by
15 Legislative Council Resolution No. 18-390; and

16 **WHEREAS,** by Chukut Kuk District Resolution No. 2018-53, the Chukut Kuk District Council
17 authorized an amendment to its FY 2019 Chukut Kuk District Budget which is
18 incorporated by this reference increasing the overall FY 2019 Chukut Kuk District
19 Budget from \$2,017,635.31 to \$2,032,635.31 funded by Mining Royalty savings in
20 the amount of \$15,000.00 and authorized to expend funds by Legislative Council
21 Resolution No. 18-482; and

22 **WHEREAS,** by Chukut Kuk District Resolution No. 2019-03 the Chukut Kuk District Council
23 authorized an amendment to the FY 2019 Tecolote Community Budget which is
24 incorporated by this reference increasing the overall FY 2019 Chukut Kuk District
25 Budget from \$2,032,635.31 to \$2,111,180.30; and

26 **WHEREAS,** by Chukut Kuk District Resolution No. 2019-08 the Chukut Kuk District Council
27 authorized an amendment to the FY 2019 West Villages Community Budget which
28 is incorporated by this reference increasing the overall FY 2019 Chukut Kuk
29 District Budget from \$2,111,180.30 to \$2,130,128.61; and

30 **WHEREAS,** by Chukut Kuk District Resolution No. 2019-09 the Chukut Kuk District Council
31 authorized an amendment to the FY 2019 Miguel Community Budget which is
32 incorporated by this reference; and

1 **WHEREAS, the Budget and Finance Committee has reviewed the amendments to the FY 2019**
2 **Tecolote Community, West Villages and Miguel Community Budgets and**
3 **recommends its approval.**

4 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
5 **amendment to the FY 2019 Chukut Kuk District Budget as follows:**

6 **1. Tecolote Community Budget Amendment No. 1 to carryover**

7 **FY 2016 Mining Royalties in the amount of \$11,467.44**

8 **FY 2018 surplus funds in the amount of \$67,077.55**

9 **Amend justification to Line Item 810-Professional Services**

10 **2. West Villages Community Budget Amendment No. 1 to carryover**

11 **FY2018 Surplus Funds in the amount of \$7,355.53**

12 **FY 2014 Mining Royalties in the amount of \$6,345.23**


13 **FY 2016 Mining Royalties in the amount of \$5,247.55**

14 **3. Miguel Community Budget Amendment No. 1 to transfer funds in the amount**
15 **of \$6,670.61 to various line items to cover anticipated costs.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 Chukut**
17 **Kuk District Budget shall be managed and expended in accordance with Article**
18 **IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's**
19 **laws provided that any amendments or modifications shall be authorized under**
20 **District Council resolution and submitted for prior approval by the Tohono**
21 **O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND**
23 **day of MARCH, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
25 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
28 **(48 Stat.984).**




