

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Health and Human Services Healthy
O'odham Promotion Program Budget Amendment No. 1)**

RESOLUTION NO. 19-091

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Department of Health and Human Services Healthy O'odham**
8 **Promotion Program Budget in the amount of \$2,241,130.00 was approved by**
9 **Resolution No. 19-041; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2020 Healthy O'odham Promotion Program Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2020 Department of Health and Human Services Healthy O'odham**
15 **Promotion Program Budget Amendment No. 1 will increase the FY 2020**
16 **Department of Health and Human Services Healthy O'odham Promotion**
17 **Program Budget by \$1,751,824.17 from \$2,241,130.00 to \$3,992,954.17; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2020 Department of Health and Human Services Healthy**
20 **O'odham Promotion Program Budget Amendment No. 1 and recommend its**
21 **approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2020 Department of Health and Human Services Healthy O'odham Promotion**
24 **Program Budget Amendment No. 1 effective January 1, 2019, which includes a**
25 **\$1,751,824.17 increase from \$2,241,130.00 to \$3,992,954.17 that shall be funded**
26 **by prior years' savings from the Special Diabetes Program for Indians.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2020 Department of Health and Human Services Healthy O'odham**
30 **Promotion Program Budget as amended, provided however, that any**
31 **amendments or modifications shall be submitted for prior approval by the**
32 **Tohono O'odham Legislative Council.**




