1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 19-079 was approved on**
2 **March 4, 2019 to approve the transfer of funds to the Schuk Toak District RBC**
3 **Wealth Management Investment Account; and**

4 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 19-079 incorrectly**
5 **identified the Schuk Toak District RBC Wealth Management Investment Account**
6 **as "The Schuk Toak District RVC Wealth Management Investment Account"; and**


7 **WHEREAS, the Schuk Toak District brought this typographical error to the attention of the**
8 **Legislative Council and requested a correction; and**

9 **WHEREAS, the Budget and Finance Committee has reviewed this correction to Resolution**
10 **No. 19-079 and recommends its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED by Tohono O'odham Legislative Council that it hereby**
12 **amends Resolution No. 19-079 to reflect the correct name of the Schuk Toak**
13 **District RBC Wealth Management Investment Account.**


14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND**

19 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
20 **16 of the Act of June 18, 1934 (48 Stat.984).**


