

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 77-80, 41-82, 26-86, 40-84, 138-87, 423-90,  
92-247, 15-389, and 18-098 to Reflect Legal Name Changes of Enrolled Members)**

**RESOLUTION NO. 19-095**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications and**  
7 **making recommendations to the Legislative Council regarding the eligibility of**  
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**  
10 **O'odham Legislative Council shall determine whether an application is approved**  
11 **for membership and its determination, along with the resolution number and**  
12 **date of enactment, shall be provided to the applicant; and**


13 **WHEREAS, the Enrollment Program has received the official documents showing the legal**  
14 **name changes of enrolled members due to a variety of reasons, such as marriage,**  
15 **divorce, or legal adoption; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 77-80, 41-**  
17 **82, 26-86, 40-84, 138-87, 423-90, 92-247, 15-389, and 18-098 be amended to reflect**  
18 **the amended names for the members identified in the April 2019 Amended**  
19 **Enrollment Resolution Summary, which is incorporated by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
21 **Nos. 77-80, 41-82, 26-86, 40-84, 138-87, 423-90, 92-247, 15-389, and 18-098 are**  
22 **amended upon the effective date of those resolutions to reflect the legal name**  
23 **changes for the members identified in the April 2019 Amended Enrollment**  
24 **Resolution Summary.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup>**  
26 **day of APRIL, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
29 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
31 **16 of the Act of June 18, 1934 (48 Stat.984).**
