

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Public Safety Tohono O'odham Nation Police
West Valley Resort Budget Amendment No. 1)**

RESOLUTION NO. 19-098

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Public Safety Tohono O'odham Nation Police West**
8 **Valley Resort Budget in the amount of \$2,291,784.38 was approved by Resolution**
9 **No. 18-339; and**

10 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
11 **approval its FY 2019 Tohono O'odham Nation West Valley Resort Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2019 Department of Public Safety Tohono O'odham Nation Police West**
15 **Valley Resort Budget Amendment No. 1 will not increase the FY 2019 Tohono**
16 **O'odham Nation Police West Valley Resort Budget; and**

17 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
18 **2019 Department of Public Safety Tohono O'odham Nation Police West Valley**
19 **Resort Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2019 Department of Public Safety Tohono O'odham Nation Police West Valley**
22 **Resort Budget Amendment No. 1, effective October 1, 2018, which does not change**
23 **the total budget amount.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2019 Department of Public Safety Tohono O'odham Nation Police**
27 **West Valley Resort Budget as amended, provided however, that any amendments**
28 **or modifications shall be submitted for prior approval by the Tohono O'odham**
29 **Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
31 **day of APRIL, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
