

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 HICKIWAN DISTRICT INITIATIVE NO. INT-01-14 BUDGET)**

RESOLUTION NO. 19-100

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono O'odham**
8 **Nation, and all expenditures of these funds shall be by checks signed by such**
9 **treasurer or other authorized officer and the chairman or vice chairman of**
10 **the district council.**

12 **WHEREAS, by Legislative Council Resolution No. 15-275, the HICKIWAN DISTRICT received**
13 **Initiative No. INT-01-14 Funds in the amount of \$126,260.07; and**

14 **WHEREAS, by HICKIWAN DISTRICT COUNCIL Resolution No. HDC-19-016, the HICKIWAN**
15 **District has authorized and submitted for review and approval the FY 2019**
16 **HICKIWAN DISTRICT INITIATIVE No. INT-01-14 Budget, which is incorporated by**
17 **this reference, in the amount of \$126,260.07; and**

18 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 HICKIWAN**
19 **District Initiative No. INT-01-14 Budget and recommends its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2019 HICKIWAN DISTRICT INITIATIVE No. INT-01-14 Budget in the amount of**
22 **\$126,260.07 that shall be funded by HICKIWAN DISTRICT INITIATIVE No. INT-01-**
23 **14 Funds.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 HICKIWAN**
25 **District Initiative No. INT-01-14 Budget shall be managed and expended in**
26 **accordance with Article IX, Section 7 of the Constitution of the Tohono**
27 **O'odham Nation and the Nation's laws, provided that any amendments or**
28 **modifications shall be authorized under District Council resolution and**
29 **submitted for prior approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
31 **day of APRIL, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
33 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
34 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
35 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
36 **(48 Stat.984).**


