

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Hickiwan District Mining Royalty Budget)**

RESOLUTION NO. 19-101

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono O'odham**
8 **Nation, and all expenditures of these funds shall be by checks signed by such**
9 **treasurer or other authorized officer and the chairman or vice chairman of**
10 **the district council.**

12 **WHEREAS, the Hickiwan District received mining royalty allocations in the amount of**
13 **\$81,438.65 for FY 2014 by Legislative Council Resolution No. 13-460, and the**
14 **amount of \$115,253.30 for FY 2016 by Legislative Council Resolution No. 16-**
15 **017; and**

16 **WHEREAS, by Hickiwan District Council Resolution No. HDC-19-017, the Hickiwan**
17 **District has authorized and submitted for review and approval the FY 2019**
18 **Hickiwan District Mining Royalty Budget, which is incorporated by this**
19 **reference in the amount of \$196,691.95; and**


20 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Hickiwan**
21 **District Mining Royalty Budget and recommends its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2019 Hickiwan District Mining Royalty Budget in the amount of**
24 **\$196,691.95 that shall be funded by FY 2014 and FY 2016 mining royalties.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 Hickiwan**
26 **District Mining Royalty Budget shall be managed and expended in**
27 **accordance with Article IX, Section 7 of the Constitution of the Tohono**
28 **O'odham Nation and the Nation's laws, provided that any amendments or**
29 **modifications shall be authorized under District Council resolution and**
30 **submitted for prior approval by the Tohono O'odham Legislative Council.**


31 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST**
32 **day of APRIL, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
33 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
34 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
35 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
36 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
37 **(48 Stat.984).**


