

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Water Resources Department Environmental Protection
Agency Budget Amendment No. 1)**

RESOLUTION NO. 19-105

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds or the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Water Resources Department Environmental Protection Agency
8 ("EPA") Budget in the amount of \$135,000.00 was approved by Resolution No. 18-
9 300; and

10 **WHEREAS,** the Tohono O'odham Nation Grants and Contracts Office has identified Water
11 Resources Department EPA Budget carry-forward funds in the amount of
12 \$31,651.02; and

13 **WHEREAS,** the Water Resources Department has prepared and submitted for review and
14 approval its FY 2019 EPA Budget Amendment No. 1, which is incorporated by this
15 reference and which will adjust operational and/or personnel line items; and

16 **WHEREAS,** the FY 2019 Water Resources Department EPA Budget Amendment No. 1 will
17 increase the FY 2019 Water Resources Department Budget by \$31,651.02 from
18 \$135,000.00 to \$166,651.02; and

19 **WHEREAS,** the Water Resources and Budget and Finance Committees have reviewed the FY
20 2019 Water Resources Department EPA Budget Amendment No. 1 and
21 recommend its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
23 FY 2019 Water Resources Department EPA Budget Amendment No. 1 effective
24 October 1, 2018, which includes a \$31,651.02 increase from \$135,000.00 to
25 \$166,651.02 that shall be funded by FY 2018 carry-forward funds.

26 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the
27 Tohono O'odham Nation chairperson or any designated official is authorized to
28 administer and expend the FY 2019 Water Resources Department EPA Budget as
29 amended, provided that any amendments or modifications shall be submitted
30 for prior approval by the Tohono O'odham Legislative Council.
