

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Department of Health and Human Services Division of Behavioral Health Family Violence Prevention Grant Budget Amendment No. 1)**

**RESOLUTION NO. 19-106**

1   **WHEREAS,**    the Tohono O'odham Legislative Council is authorized "to manage any funds  
2                    within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3                    these funds for the benefit of the nation and its members" provided that "[a]ll  
4                    expenditures of these funds shall be pursuant to appropriations or budgets"  
5                    authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6                    Nation, Article VI, Section 1(d)(2)); and

7   **WHEREAS,**    the FY 2019 Department of Health and Human Services ("DHHS") Division of  
8                    Behavioral Health Family Violence Prevention Grant Budget in the amount of  
9                    \$73,305.00 was approved by Resolution No. 18-333; and

10 **WHEREAS,**    the DHHS Division of Behavioral Health has prepared and submitted for review  
11                    and approval its FY 2019 Family Violence Prevention Grant Budget Amendment  
12                    No. 1, which is incorporated by this reference and which will adjust operational  
13                    and/or personnel line items; and

14 **WHEREAS,**    the FY 2019 DHHS Division of Behavioral Health Family Violence Prevention  
15                    Grant Budget Amendment No. 1 will increase the FY 2019 DHHS Division of  
16                    Behavioral Health Family Violence Prevention Grant Budget by \$143,242.00 from  
17                    \$73,305.00 to \$216,547.00; and

18 **WHEREAS,**    the Health and Human Services and Budget and Finance Committees have  
19                    reviewed the FY 2019 DHHS Division Of Behavioral Health Family Violence  
20                    Prevention Grant Budget Amendment No. 1 and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
22                    FY 2019 Department of Health and Human Services Division of Behavioral Health  
23                    Family Violence Prevention Grant Budget Amendment No. 1, effective October 1,  
24                    2018, which includes a \$143,242.00 increase from \$73,305.00 to \$216,547.00 that  
25                    shall be funded by the Nation's general fund pending reimbursement from  
26                    grantor.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
28                    Nation chairperson or any designated official is authorized to administer and  
29                    expend the FY 2019 Department of Health and Human Services Division of  
30                    Behavioral Health Family Violence Grant Budget as amended, provided however,  
31                    that any amendments or modifications shall be submitted for prior approval by  
32                    the Tohono O'odham Legislative Council.
