

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 San Xavier District Budget Amendment No. 2)

RESOLUTION NO. 19-108

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Tohono O'odham Constitution of the
2 Tohono O'odham Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by a
6 treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono O'odham
8 Nation, and all expenditures of these funds shall be by checks signed by such
9 treasurer or other authorized officer and the chairman or vice chairman of
10 the district council.

12 **WHEREAS,** the FY 2019 San Xavier District Budget in the amount of \$13,331,452.00 was
13 authorized by San Xavier District Council Resolution No. SXDC 08-18-06 and
14 approved by Legislative Council Resolution No. 18-391, and subsequently
15 amended by Legislative Council Resolution No. 18-477 in the amount of
16 \$13,608,426.79; and

17 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 03-19-01, the San Xavier
18 District has authorized and submitted for review and approval its FY 2019 San
19 Xavier District Budget Amendment No. 2, which is incorporated by this reference
20 and which will amend the San Xavier District 110-Senior Services Department
21 Budget; and

22 **WHEREAS,** the FY 2019 San Xavier District Budget Amendment No. 2 will increase the FY 2019
23 San Xavier District Budget by \$14,878.32 from \$13,608,426.79 to \$13,623,305.11;
24 and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 San Xavier District
26 Budget Amendment No. 2 and recommends approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2019 San Xavier District Budget Amendment No. 2, which includes a \$14,878.32
29 increase from \$13,608,426.79 to \$13,623,305.11 that shall be funded by the
30 insurance claim payment to the Nation on behalf of the San Xavier District due to
31 fire loss.

32 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019 San
33 Xavier District Budget as amended shall be managed and expended in
34 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
35 Nation and the Nation's laws, provided that any amendments or modifications

1 shall be authorized under District Council resolution and submitted for prior
2 approval by the Tohono O'odham Legislative Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD
4 day of APRIL, 2019 at a meeting at which a quorum was present with a vote of 3.084.6 FOR; -0-
5 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
6 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
7 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
9 (48 Stat.984).
