

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Community Health Budget Amendment No. 2)**

RESOLUTION NO. 19-109

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Health and Human Services Division of Community**
8 **Health Budget in the amount of \$2,756,396.00 was approved by Resolution No. 18-**
9 **340 and amended by Resolution No. 18-447 in the amount of \$3,362,046.65; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2019 Division of Community Health Budget**
12 **Amendment No. 2, which is incorporated by this reference and which will adjust**
13 **personnel, operational and/or capital line items; and**

14 **WHEREAS, the FY 2019 Department of Health and Human Services Division of Community**
15 **Health Budget Amendment No. 2 will not change the total budget amount; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
17 **reviewed the FY 2019 Department of Health and Human Services Division of**
18 **Community Health Budget Amendment No. 2 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2019 Department of Health and Human Services Division of Community Health**
21 **Budget Amendment No. 2 effective October 1, 2018, which will not change the total**
22 **budget amount of \$3,362,046.65.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Department of Health and Human Services Division of**
26 **Community Health Budget as amended, provided however, that any amendments**
27 **or modifications shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
30 **day of APRIL, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
