

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Non-Disclosure Agreement Between the Arizona Department
of Water Resources and the Tohono O'odham Nation)**

RESOLUTION NO. 19-117

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**
2 **negotiate and conclude agreements and contracts on behalf of the Tohono**
3 **O'odham Nation with Federal, State and local governments..." (Constitution of**
4 **the Tohono O'odham Nation, Article VI, Section 1(f)); and**

5 **WHEREAS, the Tohono O'odham Nation ("Nation") is currently in negotiations with the State**
6 **of Arizona through the Arizona Department of Water Resources ("ADWR") to settle**
7 **water rights claims for the Tohono O'odham Reservation and trust land; and**

8 **WHEREAS, during the course of negotiations, both parties will inevitably need to share**
9 **information that is sensitive in nature; and**

10 **WHEREAS, the Nation has an interest in preventing the disclosure of sensitive information;**
11 **and**

12 **WHEREAS, the Domestic Affairs and Water Resources Committees have reviewed the Non-**
13 **Disclosure Agreement and recommends that it be approved.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **Non-Disclosure Agreement substantially in the form attached and authorizes the**
16 **Chairperson of the Nation to execute it and any related documents reasonably**
17 **necessary to implement the Non-Disclosure Agreement.**


18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**

21 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
