

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Hewel Ni'ok KOHN Corporation for Public Broadcasting
Community Service Grant Unrestricted Budget Amendment No. 1)**

RESOLUTION NO. 19-120

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Hewel Ni'ok KOHN Corporation for Public Broadcasting ("CPB")**
8 **Community Service Grant ("CSG") Unrestricted budget in the amount of**
9 **\$213,434.68 was approved by Resolution No. 18-302; and**

10 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2019**
11 **KOHN CPB CSG Unrestricted Budget Amendment No. 1, which is incorporated by**
12 **this reference and which will adjust operational and/or personnel line items; and**

13 **WHEREAS, the FY 2019 Hewel Ni'ok KOHN CPB CSG Unrestricted Budget Amendment No. 1**
14 **will decrease the FY 2019 Hewel Ni'ok KOHN CPB CSG Unrestricted Budget by**
15 **\$18,411.25 from \$213,434.68 to \$195,023.43; and**

16 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed the**
17 **FY 2019 Hewel Ni'ok KOHN CPB CSG Unrestricted Budget Amendment No. 1 and**
18 **recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2019 Hewel Ni'ok KOHN CPB CSG Unrestricted Budget Amendment No. 1**
21 **effective October 1, 2018, which includes a \$18,411.25 decrease from \$213,434.68**
22 **to \$195,023.43.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Hewel Ni'ok KOHN CPB CSG Unrestricted Budget as amended,**
26 **provided that any amendments or modifications shall be submitted for prior**
27 **approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
29 **day of APRIL, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
