2		within the exclusive control of the Tohono O'odham Nation and to appropriate
3		these funds for the benefit of the nation and its members" provided that "[a]ll
4		expenditures of these funds shall be pursuant to appropriations or budgets"
5		authorized by resolution or ordinance (Constitution of the Tohono O'odham
6		Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS,	the FY 2019 Hewel Ni'ok KOHN Corporation for Public Broadcasting ("CPB")
8		Community Service Grant ("CSG") Restricted Budget in the amount of \$66,292.13
9		was approved by Resolution No. 18-303; and
10	WHEREAS,	Hewel Ni'ok has prepared and submitted for review and approval its FY 2019
11		KOHN CPB CSG Restricted Budget Amendment No. 1, which is incorporated by this
12		reference and which will adjust operational and/or personnel line items; and
13	WHEREAS,	the FY 2019 Hewel Ni'ok KOHN CPB CSG Restricted Budget Amendment No. 1 will
14		increase the FY 2019 Hewel Ni'ok KOHN CPB CSG Restricted Budget \$33,384.34
15		from \$66,292.13 to \$99,676.47 and adjust the indirect cost to the new approved
16		rate of 19.93%; and
17	WHEREAS,	the Cultural Preservation and Budget and Finance Committees have reviewed the
18		FY 2019 Hewel Ni'ok KOHN CPB CSG Restricted Budget Amendment No. 1 and
19		recommend its approval.
20	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
21		FY 2019 Hewel Ni'ok KOHN CPB CSG Restricted Budget Amendment No. 1, effective
22		October 1, 2018, which includes a \$33,384.34 increase from \$66,292.13 to
23		\$99,676.47 that shall be funded by the Nation's general fund pending
24		reimbursement by the grantor, and adjusts the indirect cost to the new approved
25		rate of 19.93%.
26	BE IT FINALL	Y RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
27		Nation chairperson or any designated official is authorized to administer and
28		expend the FY 2019 Hewel Ni'ok KOHN CPB CSG Restricted Budget as amended,
29		provided that any amendments or modifications shall be submitted for prior
30		approval by the Tohono O'odham Legislative Council.
