

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Hewel Ni'ok Administration Budget Amendment No. 1)**

**RESOLUTION NO. 19-122**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Hewel Ni'ok Administration Budget in the amount of \$564,461.77 was**  
8 **approved by Resolution No. 18-339; and**

9 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2019**  
10 **Hewel Ni'ok Administration Budget Amendment No. 1, which is incorporated by**  
11 **this reference and which will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2019 Hewel Ni'ok Administration Budget Amendment No. 1 will not change**  
13 **the original budget amount of \$564,461.77; and**


14 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have reviewed**  
15 **the FY 2019 Hewel Ni'ok Administration Budget Amendment No. 1 and**  
16 **recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2019 Hewel Ni'ok Administration Budget Amendment No. 1 effective October 1,**  
19 **2018 in the amount of \$564,461.77, which does not change the original budget**  
20 **amount.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2019 Hewel Ni'ok Administration Budget as amended, provided**  
24 **that any amendments or modifications shall be submitted for prior approval by**  
25 **the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
27 **day of APRIL, 2019 at a meeting at which a quorum was present with a vote of 3,084,6 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**
