

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Natural Resources Rodeo Queen Supplemental Budget)

RESOLUTION NO. 19-127

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "all**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance and to "promote, protect, and provide for**
6 **public health, peace, morals, education and general welfare of the Tohono**
7 **O'odham Nation and its members" (Constitution of the Tohono O'odham Nation,**
8 **Article VI, Section 1(d)(2) and Section 1(c)(2)); and**

9 **WHEREAS, as part of the annual Tohono O'odham Nation Rodeo and Fair, a Rodeo Queen is**
10 **selected to represent the Tohono O'odham Nation for the year at official**
11 **engagements such as rodeos and parades, pageants, conferences, public**
12 **hearings, district meetings, and other similar engagements; and**

13 **WHEREAS, during an official engagement, the 2018 Tohono O'odham Nation Rodeo Queen's**
14 **horses were killed in an accident; and**

15 **WHEREAS, no insurance compensation or other source of funds are available to assist the**
16 **2018 Tohono O'odham Nation Rodeo Queen with the costs of purchasing another**
17 **horse; and**

18 **WHEREAS, an appraisal report for the two horses, one of which was used to compete in rodeo**
19 **events and the other was used during parades and similar official engagements,**
20 **valued each from a range of \$20,000-\$100,000; and**

21 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
22 **recommend appropriating \$20,000 to the 2018 Tohono O'odham Nation Rodeo**
23 **Queen to assist with the purchase of another horse; and**

24 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
25 **approval its FY 2019 Rodeo Queen Supplemental Budget, which is incorporated**
26 **by this reference, in the amount of \$20,000.00 to be funded by the Nation's general**
27 **surplus funds; and**

28 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
29 **have reviewed the FY 2019 Department of Natural Resources Rodeo Queen**
30 **Supplemental Budget and recommend its approval.**

31 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
32 **FY 2019 Department of Natural Resources Rodeo Queen Supplemental Budget,**
33 **effective October 1, 2018 in the amount of \$20,000.00 which shall be funded by the**
34 **Nation's general surplus funds, provided that:**
