

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Enrollment Resolution Nos. 164-83, 303-88, 91-108, 93-443, 98-034, 01-589,**  
**11-402, 14-465 and 18-350 to Reflect Legal Name Changes of Enrolled Members)**

RESOLUTION NO. 19-130

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to enact laws  
2 and ordinances governing the enrollment and adoption of members (Article II,  
3 Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono  
4 O'odham Nation); and

5 **WHEREAS,** Articles VI and VII of the Nation's Enrollment Ordinance provide that the  
6 Enrollment Committee is responsible for reviewing enrollment applications and  
7 making recommendations to the Legislative Council regarding the eligibility of  
8 applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and

9 **WHEREAS,** Article VIII of the Nation's Enrollment Ordinance provides that the Tohono  
10 O'odham Legislative Council shall determine whether an application is approved  
11 for membership and its determination, along with the resolution number and  
12 date of enactment, shall be provided to the applicant; and

13 **WHEREAS,** the Enrollment Program has received the official documents showing the legal  
14 name changes of enrolled members due to a variety of reasons, such as marriage,  
15 divorce, or legal adoption; and

16 **WHEREAS,** the Enrollment Program therefore recommends that Resolution Nos. 164-83,  
17 303-88, 91-108, 93-443, 98-034, 01-589, 11-402, 14-465 and 18-350 be amended to  
18 reflect the amended names for the members identified in the May 2019 Amended  
19 Enrollment Resolution Summary, which is incorporated by this reference.

20 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
21 Nos. 164-83, 303-88, 91-108, 93-443, 98-034, 01-589, 11-402, 14-465 and 18-350 are  
22 amended upon the effective date of those resolutions to reflect the legal name  
23 changes for the members identified in the May 2019 Amended Enrollment  
24 Resolution Summary.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>  
26 day of MAY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-  
27 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by  
28 Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham  
29 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
30 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
31 16 of the Act of June 18, 1934 (48 Stat.984).
