

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution Nos. 13-066 (March 2013), 19-005 (January 2019), and 19-071 (March 2019) "Approving the Monthly Age 18 Report for March 2013, January 2019, and March 2019 of Tohono O'odham Eligible Minor Members and Authorizing Distribution of the Per Capita Payments and Interest Held in Trust on Their Behalf by Wells Fargo Bank")**

**RESOLUTION NO. 19-133**

1 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the  
2 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes  
3 per capita payments to the Nation's members provided that sufficient gaming  
4 revenues are available; and

5 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities within the Tohono  
6 O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize  
7 per capita distribution payments in accordance with the Initiative (Legislative  
8 Council Resolution No. 97-303); and

9 **WHEREAS,** the Trust Agreement with Wells Fargo Bank requires that a listing of all minor  
10 beneficiaries turning 18 that month be presented to the Tohono O'odham  
11 Legislative Council to obtain approval to distribute the trust funds to these  
12 eligible minor members as they are no longer restricted beneficiaries; and

13 **WHEREAS,** the Tohono O'odham Legislative Council approved the minors identified on the  
14 Monthly Age 18 Report for March 2013, January 2019, and March 2019 who  
15 reached the age of 18 and is no longer restricted from receiving their per capita  
16 payments in Resolution Nos. 13-066, 19-005, and 19-071; and

17 **WHEREAS,** the Nation's Enrollment Office has identified an incorrect name on members on  
18 the Monthly Age 18 Report for March 2013, January 2019, and March 2019; and

19 **WHEREAS,** the Nation's Enrollment Office recommends that the names of the members be  
20 amended on the Monthly Age 18 Report for March 2013, January 2019, and March  
21 2019.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby  
23 amends Resolution Nos. 13-066, 19-005, and 19-071, "Approving the Monthly Age  
24 18 Report for March 2013, January 2019, and March 2019 of Tohono O'odham  
25 Eligible Minor Members and Authorizing Distribution of the Per Capita Payments  
26 and Interest Held in Trust on Their Behalf by Wells Fargo Bank", to reflect the  
27 correct names of the members in accordance with the attached Monthly Age 18  
28 Report Amendment May 2019.

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
30 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
31 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
32 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
33 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat.984).**
