

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Department of Education One Stop Division Public Law (PL)  
102-477 Carry Forward Budget)**

**RESOLUTION NO. 19-139**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation Grants and Contracts Office has identified  
8 Department of Education One Stop Division Public Law PL 102-477 carry forward  
9 funds in the amount of \$665,377.21; and

10 **WHEREAS,** the Department of Education has prepared and submitted for review and  
11 approval its FY 2019 One Stop Division PL 102-477 Carry Forward Budget, which is  
12 incorporated by this reference and which will adjust personnel and/or  
13 operational line items; and

14 **WHEREAS,** the Education Department One Stop Division has prepared and submitted for  
15 review and approval its FY 2019 One Stop Division PL 102-477 Carry Forward  
16 Budget, which are incorporated by this reference, in the total amount of  
17 \$665,377.21; and

18 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
19 reviewed the FY 2019 Education Department One Stop Division PL 102-477 Carry  
20 Forward Budget and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
22 FY 2019 Department of Education One Stop Division PL 102-477 Carry Forward  
23 Budget in the total amount of \$665,377.21.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
25 Nation chairperson or any designated official is authorized to administer and  
26 expend the FY 2019 Education Department One Stop Division PL 102-477 Carry  
27 Forward Budget, provided however, that any amendments or modifications shall  
28 be submitted for further prior approval by the Tohono O'odham Legislative  
29 Council.

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
31 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
32 **AGAINST; [02] NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
36 **18, 1934 (48 Stat.984).**
