

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Education Child Care & Development
Fund Discretionary Budget Amendment #1)**

RESOLUTION NO. 19-141

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Education Child Care and Development-Discretionary**
8 **Budget in the amount of \$678,073.00 was approved by Resolution No. 18-309; and**

9 **WHEREAS, the Department of Education Child Care Services has prepared and submitted for**
10 **review and approval its FY 2019 Child Care and Development Fund-Discretionary**
11 **Budget Amendment No. 1, which is incorporated by this reference and which will**
12 **adjust operational and/or personnel line items; and**

13 **WHEREAS, the FY 2019 Department of Education Child Care and Development Fund-**
14 **Discretionary Budget Amendment No. 1 will increase the Department of**
15 **Education FY 2019 Child Care and Development Fund-Discretionary Budget by**
16 **\$2,248,195.00 from \$678,073.00 to \$2,926,268.00; and**

17 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
18 **reviewed the FY 2019 Department of Education Child Care and Development**
19 **Fund-Discretionary Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2019 Department of Education Child Care and Development Fund-**
22 **Discretionary Budget Amendment No. 1 effective October 1, 2018, which includes**
23 **a \$2,248,195.00 increase from \$678,073.00 to \$2,926,268.00 that shall be funded by**
24 **the Nation's general fund pending reimbursement from the grantor.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2019 Department of Education Child Care and Development Fund**
28 **Discretionary Budget as amended, provided that any amendments or**
29 **modifications shall be submitted for prior approval by the Tohono O'odham**
30 **Legislative Council.**
