

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Schuk Toak District – San Isidro Community Budget
Amendment No. 1)**

RESOLUTION NO. 19-144

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** the FY 2019 Schuk Toak District Budget in the amount of \$4,220,905.49 was
13 **authorized by Schuk Toak District Council Resolution No. ST-08-30-18-072 and**
14 **approved by Legislative Council Resolution No. 18-389; and**

15 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-04-13-19-039 the Schuk Toak
16 **District has authorized and submitted for review and approval its FY 2019 San**
17 **Isidro Community Budget Amendment No. 1, which is incorporated by this**
18 **reference and which will adjust operational and/or personnel line items; and**

19 **WHEREAS,** the FY 2019 Schuk Toak District – San Isidro Community Budget Amendment No.
20 **1 will not change the total budget amount; and**

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Schuk Toak District
22 **– San Isidro Community Budget Amendment No. 1 and recommends its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 **FY 2019 Schuk Toak District – San Isidro Community Budget Amendment No. 1,**
25 **which does not change the total budget amount of \$4,220,905.49.**

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019 Schuk
27 **Toak District – San Isidro Community Budget as amended shall be managed and**
28 **expended in accordance with Article IX, Section 7 of the Constitution of the**
29 **Tohono O'odham Nation and the Nation's laws, provided that any amendments or**
30 **modifications shall be authorized under District Council resolution and**
31 **submitted for prior approval by the Tohono O'odham Legislative Council.**
