

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Professional Services Agreement Amendment No. 1 between the**  
**Tohono O'odham Nation and Garden House, Inc.)**

**RESOLUTION NO. 19-151**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to consult, negotiate and**  
2 **conclude agreements and contracts on behalf of the Tohono O'odham Nation with**  
3 **Federal, State and local governments and other Indian tribes or their**  
4 **departments, agencies, or political subdivisions, or with private persons or**  
5 **organizations on all matters within the authority of the Tohono O'odham**  
6 **Council." (Constitution, Article VI, Section 1 (f)); and**

7 **WHEREAS, the Professional Services Agreement between the Tohono O'odham Nation**  
8 **("Nation") and Garden House, Inc. ("Garden House") will allow Garden House to**  
9 **provide residential and foster care services for the Nation's Children In Need of**  
10 **Care for the period of October 1, 2018 to September 30, 2019; and**

11 **WHEREAS, the Professional Services Agreement Amendment No. 1 is in excess of \$500,000.00,**  
12 **and has been reviewed by the Office of Attorney General as required by law; and**

13 **WHEREAS, the funding for this agreement will come from the FY 2019 Department of Health**  
14 **and Human Services Division of Child Welfare Tribal Child Welfare Budget 001-**  
15 **19-6051; and**

16 **WHEREAS, the Health and Human Services Committee has reviewed the agreement and**  
17 **recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
19 **approves the Professional Services Agreement Amendment No. 1 between the**  
20 **Tohono O'odham Nation and Garden House, Inc. in substantially the form**  
21 **attached and authorizes the Tohono O'odham Nation chairperson to execute and**  
22 **administer the Agreement.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
24 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 2,852.3 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and 232.3 [03] ABSENT, pursuant to the powers vested in the Council**  
26 **by Article VI, Sections 1(c)(2), 1(d)(3), and 1(f) of the Constitution of the Tohono O'odham Nation,**  
27 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
29 **Act of June 18, 1934 (48 Stat.984).**
