

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Public Safety Environmental Protection
Office General Assistance Program Budget Amendment No. 1)

RESOLUTION NO. 19-153

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Public Safety Environmental Protection Office ("EPO")**
8 **General Assistance Program Budget in the amount of \$685,052.00 was approved**
9 **by Resolution No. 18-319; and**

10 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
11 **approval its FY 2019 EPO General Assistance Program Budget Amendment No. 1,**
12 **which is incorporated by this reference and which will adjust operational and/or**
13 **personnel line items; and**

14 **WHEREAS, the FY 2019 Department of Public Safety EPO General Assistance Program Budget**
15 **Amendment No. 1 will increase the Department of Public Safety FY 2019 EPO**
16 **General Assistance Program Budget by \$587,330.19 from \$685,052.00 to**
17 **\$1,272,382.19; and**

18 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
19 **2019 Department of Public Safety EPO General Assistance Program Budget**
20 **Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2019 Department of Public Safety Environmental Protection Office General**
23 **Assistance Program Budget Amendment No. 1, which includes a \$587,330.19**
24 **increase from \$685,052.00 to \$1,272,382.19 that shall be funded by the U.S.**
25 **Environmental Protection Agency Assistance Agreement Grant under the Indian**
26 **General Assistance Program.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2019 Department of Public Safety Environmental Protection Office**
30 **Budget as amended, provided that any amendments or modifications shall be**
31 **submitted for prior approval by the Tohono O'odham Legislative Council.**
