

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Chukut Kuk District Budget Amendment No. 3)**

RESOLUTION NO. 19-154

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

11 ; and

12 **WHEREAS,** the FY 2019 Chukut Kuk District Budget in the amount of \$2,017,635.31 was
13 authorized by Chukut Kuk District Council Resolution No. 2018-40 and approved
14 by Legislative Council Resolution No. 18-390, and subsequently amended by
15 Legislative Council Resolution No. 18-482 in the amount of \$2,032,635.31 and
16 Legislative Council Resolution No. 19-090 in the amount of \$2,130,128.61; and

17 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2019-13, the Chukut Kuk District
18 Council has authorized and submitted for approval its FY 2019 San Miguel
19 Community Budget Amendment No. 1, which is incorporated by this reference;
20 and

21 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2019-19, the Chukut Kuk District
22 Council has authorized and submitted for approval its FY 2019 New Fields
23 Community Budget Amendment No. 1 and the District Administration Budget
24 Amendment which are incorporated by these references; and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the amendments to the FY 2019
26 San Miguel Community, New Fields Community, and the District Administration
27 Budgets and recommends their approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
29 amendments to the FY 2019 Chukut Kuk District Budget as follows:

- 30 1. San Miguel Community Budget Amendment No. 1 to transfer funds in the
31 amount of \$10,000.00 within line items to cover anticipated costs and
32 which does not change the budget amount of \$40,000.00.
- 33 2. New Fields Community Budget Amendment No. 1 to carryover FY 2016
34 surplus funds in the amount of \$4,333.65 and FY 2014 Mining Royalties in

1 the amount of \$6,450.35, increasing the FY 2019 New Fields Community
2 Budget by \$10,784.00 from \$37,246.98 to \$48,030.98.


- 3 3. District Administration Budget Amendment to transfer funds in the
4 amount of \$7,000.00 within line items to cover anticipated costs and which
5 does not change the budget amount.

6 **BE IT FURTHER RESOLVED** that the FY 2019 Chukut Kuk District Budget Amendment No. 3 will
7 increase the overall FY 2019 Chukut Kuk District Budget by \$10,784.00 from
8 \$2,130,128.61 to \$2,140,912.61.

9 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019 Chukut
10 Kuk District Budget as amended shall be managed and expended in accordance
11 with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and
12 the Nation's laws provided that any amendments or modifications shall be
13 authorized under District Council resolution and submitted for prior approval by
14 the Tohono O'odham Legislative Council.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH
16 day of MAY, 2019 at a meeting at which a quorum was present with a vote of 2,852.3 FOR; -0-
17 AGAINST; -0- NOT VOTING; and 232.3 [06] ABSENT, pursuant to the powers vested in the Council
18 by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the
19 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
21 18, 1934 (48 Stat.984).


