

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Community Health Services Rocky Mountain Spotted Fever Budget)

RESOLUTION NO. 19-155

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services Division of Community Health**
8 **Services has prepared and submitted for review and approval its FY 2019 Rocky**
9 **Mountain Spotted Fever (RMSE) Budget, which is incorporated by this reference,**
10 **in the amount of \$10,291.46 to be funded from carry forward funds from the**
11 **Department of Health Services; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2019 Department of Health and Human Services Division of**
14 **Community Health Services Rocky Mountain Spotted Fever (RMSE) Budget and**
15 **recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2019 Department of Health and Human Services Division of Community Health**
18 **Services Rocky Mountain Spotted Fever Budget effective October 1, 2018 in the**
19 **amount of \$10,291.46, which shall be funded from carry forward funds from the**
20 **Department of Health Services.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2019 Department of Health and Human Services Division of**
24 **Community Health Services Rocky Mountain Spotted Fever Budget, provided that**
25 **any amendments or modifications shall be submitted for prior approval by the**
26 **Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
28 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 2,852.3 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and 232.3 [06] ABSENT, pursuant to the powers vested in the Council**
30 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
31 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**
