

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Executive Branch Gaming Office Budget Amendment No. 1)**

RESOLUTION NO. 19-160

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Executive Branch Gaming Office Budget in the amount of**
8 **\$9,684,355.71 was approved by Resolution No. 18-339; and**

9 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**
10 **2019 Gaming Office Budget Amendment No. 1, which is incorporated by this**
11 **reference, and which will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2019 Executive Branch Gaming Office Budget Amendment No. 1 will not**
13 **change the overall budget amount; and**

14 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Executive Branch**
15 **Gaming Office Budget Amendment No. 1 and recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2019 Executive Branch Gaming Office Budget Amendment No. 1, effective**
18 **October 1, 2018, which will not change the overall budget amount.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Nation chairperson or any designated official is authorized to administer and**
21 **expend the FY 2019 Executive Branch Gaming Office Budget as amended,**
22 **provided that any amendments or modifications shall be submitted for further**
23 **prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10th**
25 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 2,875.6 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and 209.0 [07] ABSENT, pursuant to the powers vested in the Council**
27 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
30 **Act of June 18, 1934 (48 Stat.984).**


