

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of Community Health Services Public Health Emergency Preparedness State Zika--EDC Program Budget)

RESOLUTION NO. 19-161

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services Division of Community Health**
8 **Services has prepared and submitted for review and approval its FY 2019 Public**
9 **Health Emergency Preparedness State Zika--EDC Program Budget, which is**
10 **incorporated by this reference, in the amount of \$18,242.75 to be funded by the**
11 **Arizona Department of Health Services; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2019 Department of Health and Human Services Division of**
14 **Community Health Services Public Health Emergency Preparedness State Zika--**
15 **EDC Program Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2019 Department of Health and Human Services Division of Community Health**
18 **Services Public Health Emergency Preparedness State Zika--EDC Program**
19 **Budget effective August 1, 2018 through July 31, 2019 in the amount of \$18,242.75,**
20 **which shall be funded by the Arizona Department of Health Services.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to administer and**
23 **expend the FY 2019 Department of Health and Human Services Division of**
24 **Community Health Services Public Health Emergency Preparedness State Zika--**
25 **EDC Program Budget, provided that any amendments or modifications shall be**
26 **submitted for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
28 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 2,875.6 FOR; -0-**
29 **AGAINST; [02] NOT VOTING; and 209.0 [05] ABSENT, pursuant to the powers vested in the Council**
30 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
31 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**




