

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 Department of Health and Human Services Division of Senior Services**  
**Title VI Part A, Title VI Part C and Title VI Nutrition Services Incentive Program Budgets)**

**RESOLUTION NO. 19-162**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Department of Health and Human Services Division of Senior Services has  
8 prepared and submitted for review and approval its FY 2020 Title VI Part A Budget  
9 in the amount of \$195,600.00; Title VI Part C Budget in the amount of \$71,700.00;  
10 and Title VI Nutrition Services Incentive Program ("NSIP") Budget in the amount  
11 of \$6,774.00, which are incorporated by this reference, to be funded by the  
12 Nation's general fund pending reimbursement by the grantor, the  
13 Administration for Community Living, pursuant to Title VI of the Older  
14 Americans Act of 1978; and

15 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
16 reviewed the FY 2020 Department of Health and Human Services Division of  
17 Senior Services Title VI Part A Budget, Title VI Part C Budget and Title VI NSIP  
18 Budget and recommend their approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2020 Department of Health and Human Services Division of Senior Services  
21 Title VI Part A Budget in the amount of \$195,600.00; Title VI Part C Budget in the  
22 amount of \$71,700.00; and Title VI NSIP Budget in the amount of \$6,774.00 for a  
23 period beginning April 1, 2019 to March 31, 2020 which shall be funded by the  
24 Nation's general fund pending reimbursement from the the grantor, the  
25 Administration for Community Living, pursuant to Title VI Older Americans Act  
26 of 1978.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
28 Nation chairperson or any designated official is authorized to administer and  
29 expend the FY 2020 Department of Health and Human Services Division of Senior  
30 Services Title VI Part A Budget, Title VI Part C Budget and Title VI NSIP Budget,  
31 provided that any amendments or modifications shall be submitted for prior  
32 approval by the Tohono O'odham Legislative Council.
