

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Department of Health and Human Services Division of Community**  
**Health Public Health Emergency Preparedness Budget Amendment No. 1)**

**RESOLUTION NO. 19-163**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the FY 2019 Department of Health and Human Services Division of Community**  
8 **Health Public Health Emergency Preparedness Budget in the amount of**  
9 **\$43,338.00 was approved by Resolution No. 18-283; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
11 **review and approval its FY 2019 Division of Community Health Public Health**  
12 **Emergency Preparedness Budget Amendment No. 1, which is incorporated by this**  
13 **reference and which will adjust and create operational and/or personnel line**  
14 **items; and**

15 **WHEREAS, the FY 2019 Department of Health and Human Services Division of Community**  
16 **Health Public Health Emergency Preparedness Budget Amendment No. 1 will**  
17 **increase the FY 2019 Division of Community Health Public Health Emergency**  
18 **Preparedness Budget by \$14,305.92 from \$43,338.00 to \$57,643.92; and**

19 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
20 **reviewed the FY 2019 Department of Health and Human Services Division of**  
21 **Community Health Public Health Emergency Preparedness Budget Amendment**  
22 **No. 1 and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
24 **FY 2019 Department of Health and Human Services Division of Community Health**  
25 **Public Health Emergency Preparedness Budget Amendment No. 1 effective July 1,**  
26 **2018 in the amount of \$57,643.92 that shall be funded by the Nation's general fund**  
27 **pending reimbursement from the State of Arizona.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
29 **Nation chairperson or any designated official is authorized to administer and**  
30 **expend the FY 2019 Department of Health and Human Services Division of**  
31 **Community Health Public Health Emergency Preparedness Budget as amended,**  
32 **provided that any amendments or modifications shall be submitted for prior**  
33 **approval by the Tohono O'odham Legislative Council.**


