

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Planning and Economic Development Department Real Property
Management Budget Amendment No. 1)

RESOLUTION NO. 19-164

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Planning and Economic Development Department Real Property**
8 **Management Budget in the amount of \$641,083.22 was approved by Resolution**
9 **No. 18-339; and**

10 **WHEREAS, the Planning and Economic Development Department has prepared and**
11 **submitted for review and approval its FY 2019 Real Property Management Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2019 Planning and Economic Development Department Real Property**
15 **Management Budget Amendment No. 1 will not change the overall total budget;**
16 **and**

17 **WHEREAS, the Commerce and Budget and Finance Committees have reviewed the FY 2019**
18 **Planning and Economic Development Department Real Property Management**
19 **Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2019 Planning and Economic Development Department Real Property**
22 **Management Budget Amendment No. 1 which will not change the overall total**
23 **budget.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2019 Planning and Economic Development Department Real**
27 **Property Management Budget as amended, provided that any amendments or**
28 **modifications shall be submitted for prior approval by the Tohono O'odham**
29 **Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
31 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 2,875.6 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and 209.0 [04] ABSENT, pursuant to the powers vested in the Council**
33 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
34 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
35 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
36 **Act of June 18, 1934 (48 Stat.984).**


