

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Executive Branch Vehicle Replacement Program Budget)**

**RESOLUTION NO. 19-165**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Office of the Chairman has identified a Vehicle Replacement Committee that**  
8 **includes the Nation's Treasurer, Controller, Budget Manager, Fleet Manager,**  
9 **Executive Directors of the Department of Public Safety and the Department of**  
10 **Health and Human Services, and appropriate staff, to develop a Vehicle**  
11 **Replacement proposal; and**

12 **WHEREAS, the Vehicle Replacement Committee has prepared and submitted for review and**  
13 **approval the FY 2019 Executive Branch Vehicle Replacement Program Budget,**  
14 **which is incorporated by this reference, in the amount of \$4,872,698.54 to be**  
15 **funded from the Nation's general fund surplus; and**

16 **WHEREAS, this budget eliminates the need for Executive Branch Departments to allocate**  
17 **funds for vehicle replacements within their existing baselines; and**

18 **WHEREAS, this budget provides for the immediate replacement of safe and dependable**  
19 **vehicles for the Executive Branch Departments in their delivery of service to the**  
20 **Nation's members; and**

21 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Executive Branch**  
22 **Vehicle Replacement Program and recommends its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
24 **FY 2019 Executive Branch Vehicle Replacement Program Budget, effective**  
25 **October 1, 2018 in the amount of \$4,872,698.54 that shall be funded by the Nation's**  
26 **general fund surplus and that any remaining unexpended funds shall be carried**  
27 **forward to complete the vehicle replacement program.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
29 **Nation chairperson or any designated official is authorized to administer and**  
30 **expend the FY 2019 Executive Branch Vehicle Replacement Program Budget,**  
31 **provided that any amendments or modifications shall be submitted to the**  
32 **Tohono O'odham Legislative Council for prior approval.**
